

What is an ERA-NET+ and what is MATERA+?

ERA-NET+ actions are an initiative of the European Commission aimed at providing additional EC financial support to those national and regional programmes that pool resources to organise a Joint Call for proposals. MATERA+ is an ERA-NET+ action designed to provide a simple mechanism for the initiation of transnational projects in the field of materials science and engineering.

The benefits of participation in the MATERA+ Call

MATERA+ offers participants a simplified introduction to the initiation and participation in R&D projects at the European level. Individual project partners seek funding from their national/regional funding agencies in accordance with the relevant programme rules. The added value is the opportunity to easily access international know-how, to gain technology and market expertise and to integrate into international value chains.

Call focus

The goal is to launch transnational, interdisciplinary, innovative projects and to narrow the gap between basic materials research and industrial applications in the following areas:

- Multi-functional Materials
- Engineering Structural Materials
- Bio-based and Bio-inspired Materials

Who is eligible to participate?

The Call is open to industry, universities, institutes and research centres. Project consortia must consist of a minimum of two partners from two different MATERA+ countries (i.e. a *transnational* project) if an SME is included; otherwise, a minimum of three partners from at least two different MATERA+ countries is required.

Funding is via national/regional funding programmes. Applicants must verify both their eligibility and the rate of financial support with the relevant national/regional funding agency (see Table).

Procedure and evaluation

Application is through a two-step process. Following the Call announcement, **prospective participants must discuss their proposal with the relevant national/regional programme and funding agency.**

The first deadline is for the Project Coordinator to submit a mandatory Pre-Proposal to MATERA+. At the same time each project partner is also required to apply for funding from their national/regional funding agency. The information detailed in the MATERA+ Pre-Proposal will meet the requirements of some MATERA+ funding agencies. However some other funding agencies will require the submission of further documents and/or supporting information. Based on evaluations at national/regional levels MATERA+ will invite selected applicants to submit a Full Proposal. The second deadline is the submission of a Full Proposal including a full project plan by the Project Coordinator to MATERA+.

MATERA+ will organise an independent evaluation of the Full Proposals according to the following criteria:

- Scientific and/or technical excellence
- Quality and efficiency of the implementation and the management
- Potential impact

This evaluation process will be completed by a panel of international experts.

The outcome of this independent evaluation will be a ranking list of proposals. Based on this ranking list MATERA+ will provide recommendations for funding to the respective funding agencies. For this MATERA+ Call the total available budget is anticipated to be in the region of €20 Million.
